1. Data Processing Policy and Principles

1) Purpose of Policy

This policy aims to ensure customers' right to access and control data generated when using products and services, and to foster an innovative data ecosystem by promoting fair data sharing. We comply with relevant laws and regulations and transparently disclose all data processing procedures.

2) Scope of Policy

This applies to all data generated and collected in the process of using the products and related services provided by our company.

a) Key Applicable Data

- **Product Usage Data:** Usage logs of smart appliances, IoT devices, function operation records, sensor data, etc.
- **Service Usage Data:** In-app activity records, user interface (UI) interaction information, etc.
- **Automatically Collected Data:** Data related to the product's status, environment, and operation (e.g., temperature, location, error codes), etc.

b) Exclusions

This policy may not apply to the following data in accordance with the exception clauses of the Data Act:

- **Core Trade Secrets:** Algorithms, design data, etc., directly related to product performance and security.

Information Infringing on the Rights of Others: Copyrighted content, communication content of third parties, etc.

- **Public Security-Related Information:** Data processed at the request of law enforcement agencies.
- **Data that is technically very difficult to access.**

3) Definitions of Key Terms

The key terms related to data are as follows:

- **Data:** Any digital information created while using a product or service.
- **Customer:** The person (individual or enterprise) who buys or rents a product to use, and who is the actual owner of this data.
- **Data Holder:** The entity that stores or manages the data, typically meaning the service provider or manufacturer. (Here, it refers to 'our company').

- **Data Recipient:** The entity that plays the role of sending data to a third party upon the customer's request.

4) How We Collect and Use Data

We collect and use data in the following ways. All data is collected based on prior consent and is not used for purposes other than those specified.

- **Automatic Collection:** Logs, usage records, error information, etc., that occur during product/service use.
- **Direct Provision:** Information entered by the user through membership registration, consultation, event participation, etc.
- **External Interworking:** Data generated when interworking with other platforms or devices.

5) Customer's Data Rights

Customers have the following rights regarding their data and can make requests at any time through this site.

- **Access:** You can check what data is being used and how.
- **Portability:** You can request to have your data transferred to another location.
- **Deletion:** You can request the deletion of data that is no longer needed.

- **LG Service Connection:**

To access data under applicable law (including the EU Data Act), you must connect and sync your product with our LG services. Unless and until you establish such a connection, we will not receive, process, or store any data from your product, and therefore no data will be available for you to access or request from us.

6) Data Sharing Criteria

We share data with third parties only in the following cases and strictly enforce security measures in accordance with relevant laws through contracts:

- **Legal Obligation:** When required by relevant laws and regulations.
- **Customer Consent:** When the customer has explicitly consented.
- **Service Provision:** When cooperating with essential external contractors for service provision.

7) Data Security Measures

We operate the following security framework to protect customer data.

- **Data Encryption:** We encrypt customer information when storing and transmitting it.
- **Access Control Management:** We grant minimum necessary access rights only to

- **Regular Security Checks:** We conduct monthly security checks and immediately fix any vulnerabilities found.
- **Incident Response:** In the event of a data breach, we immediately notify customers and respond promptly.
